

Enrolment Check & School Charge Form 2018-2019

Salesian College is part of the "Free Second Level Education Scheme". Unfortunately the funds made available from the Department of Education & Skills are not sufficient to meet the school's financial needs and consequently voluntary schools like Salesian College are under funded by approximately 25%. The Board of Management of Salesian College requests that the **School Charge of €125** is paid for all students. This school charge is required to cover the cost of: School Journal, 24 Hour Personal Insurance, Photocopying, Postage, Administration, Student Testing (CAT), House Exams, Parents Association, Sports, PE, Games, Buses, Career Guidance & Counselling Services, Materials for Practical & Optional subjects & ICT, Locker Rental & Maintenance. All students avail of these materials and resources in the school.

Two years ago we introduced an instalment payment facility. However the level of the non-payment of the second instalment has impacted on our overall school budget. The late payment of this school charge has also caused considerable administrative difficulties at the beginning of the school year as we have not been able to organise correctly our school journals, locker numbers and 24 Hour Personal Insurance. Therefore in order to ensure a well organised new school year we ask for this school charge to be paid in full by August 2018. Students who have only paid the first instalment or who have not made any payment, will not be issued with their school locker at the beginning of the school year.
